TAX DEDUCTIBLE PROJECT AND PRESCHOOL UPDATES

Tax Deductible Project Details

In 2018, in partnership with Global Development Group (GDG), we began a three year project (J352N Fiji Preschools Development Project) to raise funds for Bethel Crusade Preschools. This project has tax deductible status for all donations that go through GDG.

The first three years of this project finished at the end of 2020. For the next three years (2021-2023) we have revised the project and have compiled an updated list of goals.

The major objective of this project is:

To have eight fully functioning preschools complete with facilities that meet government and OHS standards and well-equipped, trained teachers.

The three main goals of this project are:

Goal One

Establish and upgrade preschool facilities to meet government and OHS standards.

The outcome is to have fully functioning sanitary toilet facilities and a safe learning environment in every preschool by the end of 2023.

Goal Two

Construct and upgrade playground facilities to meet government and OHS standards.

The outcome is to have a fully functioning fenced playground in every preschool by the end of 2023.

Goal Three

Improve quality of education and management of the preschools through enhancing teacher capacity.

The outcome is for preschool teachers to be professionally equipped to run preschools and deliver quality education.

Preschool Enrolment Numbers and Updates

Sigatoka

51 children are enrolled into the preschool this year and we have four teachers. Pictures of the preschool in action can be seen on pages 10 to 12.

Suva

65 children are enrolled into the preschool this year and we have five teachers. All students fall into the five year old age group. Every now and then students from University of the South Pacific come to the preschool to do their practical for three months.

Lakena

22 children are enrolled into the preschool this year and we have two teachers. The property at our Lakena preschool floods easily. This year we are hoping to level out the land and fence the property so that further building and development work can take place.

Koro Island

18 children are enrolled into the preschool this year and we have one teacher. Posts and other materials for a fence are already at the preschool, however, our workers in Fiji are waiting for some free time to travel to Koro Island to construct the fence.

Daku

6 children are enrolled into the preschool this year and we have one teacher. The preschool was severely damaged by Tropical Cyclone Yasa. In February extensive repair work took place on the preschool so that students could begin attending in March. Pictures of the repair work can be seen on page 9.

Labasa

9 children are enrolled into the preschool this year and we one teacher.

Nacavanadi

19 children are enrolled into the preschool this year and we have two teachers. The preschool is gaining popularity in the surrounding villages. Village leaders have requested for us to consider starting schools in their respective villages. In addition to this, we have been given the green light to relocate the school in Nacavanadi to a new site.

Savusavu

32 children are enrolled into the preschool this year and we have two teachers. This year we have secured a new property. The owner of the previous land had a lot of demands so we decided to step out in faith and believe for a new property. At the end 2020 God opened up a door and we secured a new property in Buca, Savusavu. The old house and preschool has been taken down and the materials have been used to construct a new house and preschool on the new property. The facilities are now complete and children have begun attending the new school. Pictures of this development can be seen on pages 3 to 8.

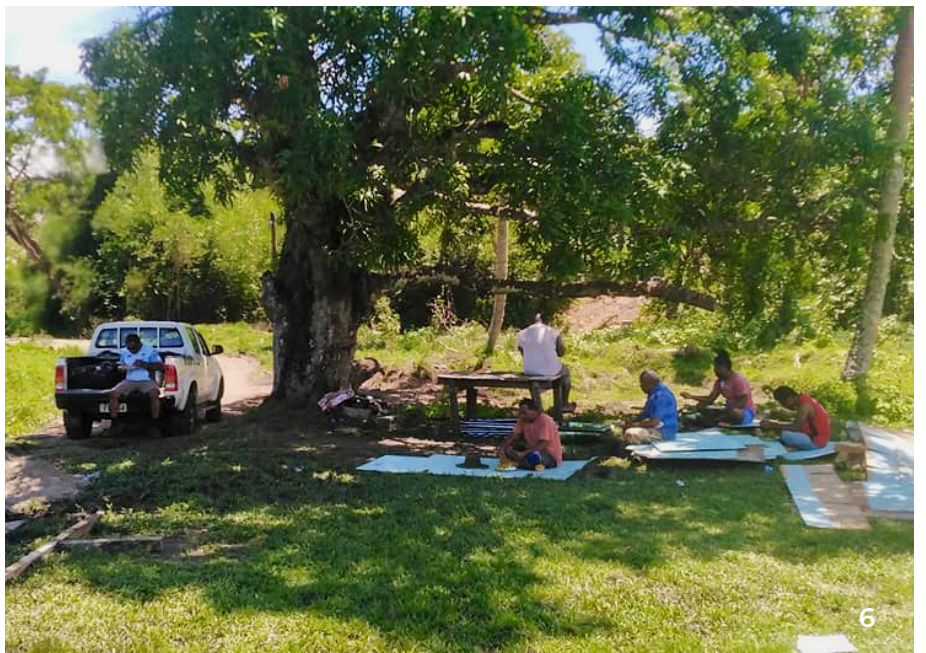




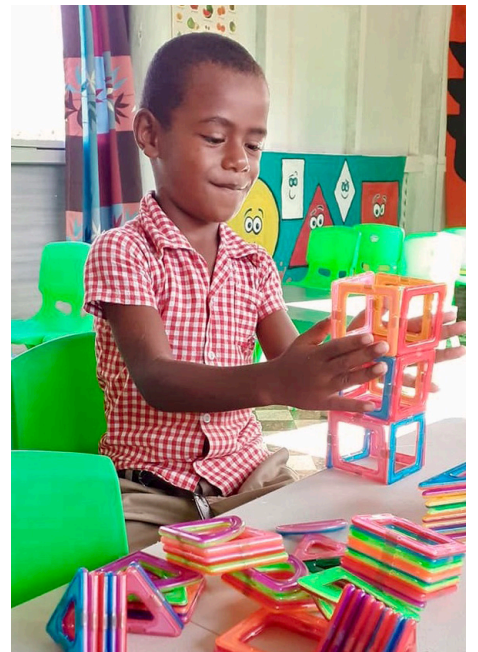
